- Personal Data We Collect -

We collect various elements of your personal data when you make contact with us through our website, https://www.josreichert.com. You are deemed to make contact by browsing our website, purchasing items offered for sale on our website, downloading free materials from our website, sending emails to the electronic addresses listed on our website (josephr@josreichert.com and purchases@josreichert.com), submitting your comments to us through our website, and by corresponding with us at any physical mailing address which we maintain for receipt of hard copy correspondence and shipments. These elements of personal data can include one or more of the following pieces of information:

- 1. Your name, your email address, and your physical address,
- 2. Your gender (e.g., by use of "Mr.", "Mrs." etc.);
- 3. Your age;
- 4. Your IP address and your browser user agent string;
- 5. Various elements of your financial information (for example, if you send us a payment by check, we will acquire the name of your banking institution, your bank's routing number, your checking account number, and your physical address as displayed on your check.)
- 6. If you make contact with us, we may also be able to infer certain information not expressly stated by you, including but not limited to: your interests, your education and profession, your hobbies, avocations, and social and political opinions.

The foregoing is not a complete list of all information that may become accessible to us when you make contact with us, but is a good faith statement of all the information we believe we can readily access.
