NOTICE OF THE TERMS OF SALE AND REFUND POLICY OF JOSEPH REICHERT, INC. (d/b/a/ JRI GUNMAKER)

All sales made by Joseph Reichert, Inc., (d/b/a JRI Gunmaker) are final, subject only to those conditions expressly stated in this Notice. Its terms control all orders placed on or after the date of its publication, May 20, 2025.

- Prices For Media Items Include Shipping Costs - - Media Items Shipped Only At “Media Rate” -

The physical objects we sell (hard copy books, drawings, CDs, and DVDs, hereafter referred to as “Media Items”) are only offered to customers with shipping addresses located within one of the fifty states of the United States of America. Our prices for Media Items include the cost of shipping them through the United States Postal Service at the “media rate”, a special postal rate applicable only to books, drawings, DVDs and CDs. United States Postal Service media rate is the only shipping method by which we ship Media Items.

- No Foreign Sales Of Media Items -

The Media Items we sell will not be shipped to any location outside of the fifty states of the United States of America. If you wish to purchase our products in physical form, you must provide a delivery address located within one of the fifty states of the United States of America.

- Terms Governing Orders For Electronic Media -

We may offer selected items from our inventory in electronic form, (hereafter referred to as “Electronic Downloads”) and make these Electronic Downloads available for purchase internationally. If you wish to receive Electronic Downloads at a location outside of the United States, you are responsible for verifying that you are allowed to access and possess such materials in the country where you will use them. We are reliably informed that accessing instructional materials on the design, making and testing of guns and ammunition is unlawful in certain countries (for example, in Great Britain and certain Commonwealth countries). Joseph Reichert, Inc., (d/b/a JRI Gunmaker) will not take responsibility for your disobedience to the laws of your own nation. Before downloading any Electronic Media we may offer, make sure that you are permitted to access information of the sort we sell. We will not take responsibility for Electronic Downloads which are blocked or scrambled by your government, and will not give refunds for Electronic Downloads which are blocked by the actions of any government. **(As of the date of publication of this Notice (May 20, 2025) we do not have any Electronic Downloads in our inventory. If we offer such for sale in the future, we may supplement this Notice with additional terms controlling their sale. By placing an order with us, you warrant that:

- We Are Not Responsible For Loss Or Damage To Media Items During Transit -**
- We Will Replace Items Which Were Shipped By Us In Damaged Condition -
- We Presume That USPS Verification Of Delivery To You Is Accurate -

We will not be responsible for damage to or loss of any media item which occurs after we have shipped it. If it is discovered that any materials we sell were defective at the time of shipment, we will replace them free of charge, provided the damaged articles are returned to us within fifteen days of delivery to the customer. **Please note that we do not provide monetary refunds under any circumstances, but only product replacement.** All shipments we make are through the United States Postal Service, and are sent with USPS tracking enabled. If the United States Postal Service tracking service registers your order as delivered to the address you provided to us when placing your order, we will presume such report to be accurate.

- We Will Only Ship To The Address Which You Provide To Us When Placing Your Order -

The delivery address you provide to us when placing your order is the address to which we will ship. Under no circumstances whatsoever will we honor any instructions to change the delivery address once your order is placed. Be advised that the shipping label we will use for your order is printed directly from the entries you make when placing your order, and we will not undertake to correct any defects in the information you enter. Make sure that such data as your zip code and any state abbreviation are correct.
